WHEREAS, San Acacia is a farming and ranching community about fourteen miles north of Socorro; and

WHEREAS, San Acacia is named for San Acacio who is said to have been a Roman soldier slain in early christian times for his faith and who was represented by the santeros as crucified and dressed in a Spanish uniform; and

WHEREAS, the change in the spelling of the name might have resulted from confusion with the acacia tree;

NOW, THEREFORE, BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO that the United States postal service and the Socorro county commission be requested to change the name of
