B. "other state funds" means:

- (1) unencumbered balances in state agency accounts appropriated by the General Appropriation Act of 1996; and
- (2) all revenue available to state agencies from sources other than the general fund and federal funds.

Section 3. FORMAT.--The general format of the appropriations set forth in the State Fair Commission

Appropriations Act with respect to symbols used, column headings and stating of amounts is that used in the General Appropriation Act of 1996.
