RELATING TO THE DWI GRANT COUNCIL; CHANGING THE MEMBERSHIP OF THE DWI GRANT COUNCIL; AMENDING A SECTION OF THE LOCAL DWI GRANT PROGRAM ACT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. Section 11-6A-4 NMSA 1978 (being Laws 1993, Chapter 65, Section 4) is amended to read:

"11-6A-4. DWI GRANT COUNCIL--MEMBERSHIP--DUTIES.--

A. The "DWI grant council" is created and shall consist of [the president of the New Mexico municipal league, the president of the New Mexico association of counties, the secretary of health or the secretary's designee, the secretary of finance and administration or the secretary's designee, the chief of the traffic safety bureau of the state highway and transportation department and two representatives of local

3	(1) a representative of the New Mexico
4	municipal league, to be selected by the board of directors of

6	(2) a representative of the New Mexico

22	B. Appointed members shall be appointed to a two-
23	year term. In the event of a vacancy, the governor shall
24	appoint a member for the remainder of the term.
25	C. The council shall meet as necessary to receive

applications, consider grant requests and award DWI grants pursuant to the Local DWI Grant Program Act. All actions of the council require the affirmative vote of a majority of the members of the council.

D. Members of the council shall be reimbursed for per diem and mileage in accordance with the Per Diem and Mileage Act."

Section 2. EFFECTIVE DATE.--The effective date of the provisions of this act is July 1, 1997.
