MAKING AN APPROPRIATION FOR CONTINUATION OF CERTAIN STATEWIDE COMMUNITY PROGRAMS FOR LOW-INCOME INDIVIDUALS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- One million dollars (\$1,000,000) is appropriated from the general fund to the community development and commodities section of the income support division of the human services department for expenditure in fiscal year 1998 for the purpose of providing statewide community service block grant funding of housing, nutrition, utility support, job referral, counseling, tutoring and outreach services and programs for low-income individuals in need of assistance. Any unexpended or unencumbered balance remaining at the end of fiscal year 1998 shall revert to the general fund.
