AN ACT

RELATING TO PUBLIC SCHOOLS; AMENDING A PROVISION OF LAW REGARDING EXCUSAL OF STUDENTS FROM SCHOOL FOR THE PURPOSE OF PARTICIPATING IN RELIGIOUS INSTRUCTION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. Section 22-12-3 NMSA 1978 (being Laws 1971, Chapter 238, Section 1) is amended to read:

"22-12-3. RELIGIOUS INSTRUCTION EXCUSAL. -- Any student may, subject to the approval of the local school board, be excused from school to participate in religious instruction for not more than one [hour] class period each school day with the written consent of his parents at a time period not in conflict with the academic program of the school. The local school board and its employees shall not assume responsibility for the religious [instructions] instruction or permit [them] it to be conducted

on	school	property.	"

Section 2. EFFECTIVE DATE. -- The effective date of the provisions of this act is July 1, 1997.
