The fund shall consist of all license fees, charges and other revenue received by the commission, less amounts paid to the state treasurer pursuant to Section 60-2D-15 NMSA 1978, 3 and all appropriations, gifts, devises, grants and donations made to the fund. Money in the fund may be expended by the 5 commission pursuant to appropriation by the legislature and budgets approved by the state budget division. 7 Interest accruing to the fund through investment of the fund shall remain 8 in the fund. Money in the fund shall not revert at the end of a fiscal year.

**B**. The fund shall be administered by the commission. Disbursements from the fund shall be made only upon warrant drawn by the secretary of finance and administration pursuant to vouchers signed by the chairman of the commission or his designee."

Section 3. A new Section 60-2D-19 NMSA 1978 is enacted to read:

"60-2D-19. [<u>NEW MATERIAL</u>] TERMINATION OF COMMISSION LIFE--DELAYED REPEAL.--The bicycle racing commission is terminated July 1, 1999 pursuant to the Sunset Act. The commission shall continue to operate pursuant to the provisions of the Bicycle Racing Act until July 1, 2000. Effective July 1, 2000, Chapter 60, Article 2D NMSA 1978 is repealed."




