BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. Section 66-3-705 NMSA 1978 (being Laws 1978, Chapter 35, Section 104) is amended to read:

"66-3-705. RIDING ON ROADWAYS AND BICYCLE PATHS. --

- A. Every person operating a bicycle upon a roadway shall ride as near to the right side of the roadway as [praticable] practicable, exercising due care when passing a standing vehicle or one proceeding in the same direction.
- B. [Persons riding bicycles upon a roadway shall not ride more than two abreast except on paths or parts of roadways set aside for the exclusive use of bicycles.

[C. Whenever a usable path for bicycles has been
provided adjacent to a roadway, bicycle riders shall use such
path and shall not use the roadway.]"

EFFECTIVE DATE. -- The effective date of the Section 2. provisions of this act is July 1, 1997.
