



A. The "work force education coordinating council" is created as an advisory council to the executive, the legislature and the state board. The council shall be composed of twenty-five members representative of the different geographical areas of the state and reflective of the diverse population of the state.

B. The president pro tempore of the senate shall appoint two senators, one from each of the two major political parties, for four-year terms or until their term of office expires.

C. The speaker of the house shall appoint two representatives, one from each of the two major political parties, for two-year terms or until their term of office expires.

D. The president of the state board shall appoint one representative of the state board to a one-year term and then to a four-year term.

E. the governor shall appoint one representative from the governor's office to a one-year term and then to a four-year term.

F. The following nineteen members shall be appointed jointly by the governor, the speaker of the house of representatives, the president pro tempore of the senate and the president of the state board:

(1) two representatives of the division, one of whom shall be the division's gender equity coordinator, one for a twoyear term and one for a four-year term;

(2) two representatives of the labor department, oneof whom shall be appointed from the state employment sector, one.116566.1

Any unexpended or unencumbered balance remaining at the end of fiscal year 1998 shall revert to the general fund.
