MAKING AN APPROPRIATION TO PURCHASE MOBILE COMPUTERS FOR PUBLIC SAFETY AND EMERGENCY RESPONSE VEHICLES IN SAN JUAN COUNTY; DECLARING AN EMERGENCY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- Eight hundred forty thousand dollars (\$840,000) is appropriated from the general fund to the local government division of the department of finance and administration for expenditure in fiscal years 1997 and 1998 to purchase mobile computers for public safety and emergency response vehicles in San Juan county. Any unexpended or unencumbered balance remaining at the end of fiscal year 1998 shall revert to the general fund.

Section 2. EMERGENCY.--It is necessary for the public peace, health and safety that this act take effect immediately.
