

14	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:
15	Section 1. DISTRICT ATTORNEY FUNDCREATED
16	ADMINISTRATIONPURPOSEThe "district attorney fund" is
17	created in the state treasury. The fund shall consist of
18	worthless check fees, preprosecution diversion fees, other
19	statutory revenues directed to the fund, appropriations, gifts,
20	grants and donations. The fund shall not revert at the end of
21	any fiscal year. Money in the fund is subject to appropriation
22	by the legislature and is for the sole purpose of meeting
23	necessary expenses incurred in the operation of the
24	administrative office of the district attorneys. Expenditures
2 <b>-</b> 25	from the fund shall be pursuant to budgets approved by the state
