20	1998 for the purpose of granting tuition scholarships to
21	students who are residents of New Mexico and who are active
22	members of the New Mexico army national guard and the New Mexico
23	air national guard. Any unexpended or unencumbered balance
24	remaining at the end of fiscal year 1998 shall revert to the
25	general fund.
