MAKING AN APPROPRIATION FOR A STUDY TO DETERMINE THE FEASIBILITY OF A SECOND HIGH SCHOOL IN THE NORTHERN SECTION OF THE BERNALILLO SCHOOL DISTRICT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- One hundred thousand dollars (\$100,000) is appropriated from the general fund to the state department of public education for expenditure in fiscal year 1998 for the purpose of conducting a study to determine the feasibility of a second high school to serve students in the northern section of the Bernalillo school district located in Sandoval county. Any unexpended or unencumbered balance remaining at the end of fiscal year 1998 shall revert to the general fund.
