MAKING AN APPROPRIATION TO THE DISTRICT ATTORNEY'S OFFICE FOR  
THE SECOND JUDICIAL DISTRICT TO PROVIDE STAFF FOR AND OPERATE A  
PRIORITY REPEAT OFFENDER PROGRAM

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- Five hundred thirty-seven  
thousand eight hundred dollars (\$537,800) is appropriated from  
the general fund to the district attorney's office for the  
second judicial district for expenditure in fiscal year 1998 for  
the purpose of paying salaries and benefits and providing  
furniture, equipment and supplies for eleven full-time  
employees, who will be the staff for the priority repeat  
offender program. The priority repeat offender program will  
target and prosecute repeat offenders. Any unexpended or  
unencumbered balance remaining at the end of fiscal year 1998
