FOR THE HEALTH CARE REFORM COMMITTEE

AND THE HEALTH AND HUMAN SERVICES COMMITTEE

RELATING TO HEALTH CARE: ENACTING A SECTION OF THE PUBLIC ASSISTANCE ACT TO REQUIRE MEDICAL ASSISTANCE TO CHILDREN AND PREGNANT WOMEN IN FAMILIES AT OR BELOW ONE HUNDRED EIGHTY-FIVE PERCENT OF THE FEDERAL POVERTY LEVEL.

"[NEW MATERIAL] MEDICAL ASSISTANCE REQUIRED FOR CHILDREN AND PREGNANT WOMEN IN FAMILIES AT OR BELOW ONE HUNDRED EIGHTY-FIVE PERCENT OF THE FEDERAL POVERTY LEVEL. -- Consistent with the eligibility criteria under the federal act, and subject to available appropriations, the human services department shall provide medical assistance through the medicaid program to children and pregnant women in families at or below one hundred
