FOR THE HEALTH CARE REFORM COMMITTEE

RELATING TO MEDICAID: PROVIDING FOR INCREASED MEDICAID REIMBURSEMENTS TO PROVIDERS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 27-2-12.3 NMSA 1978 (being Laws 1987, Section 1. Chapter 269, Section 1, as amended) is amended to read:

"27-2-12.3. MEDICAID REIMBURSEMENT--EQUAL PAY FOR EQUAL [PHYSICIANS', DENTISTS', OPTOMETRISTS', PODIATRISTS' AND PSYCHOLOGISTS' PROVIDER SERVICES -- EXCEPTION. -- The human services department shall establish a rate for the reimbursement of physicians, dentists, optometrists, podiatrists and psychologists for services rendered to medicaid patients that provides equal reimbursement for the same or similar services rendered without respect to the date on which [such] the physician, dentist, optometrist, podiatrist or psychologist

entered into practice in New Mexico, the date on which the physician, dentist, optometrist, podiatrist or psychologist entered into an agreement or contract to provide such services or the location in which such services are to be provided in the state; provided, however, that the requirements of this section shall not apply when the human services department contracts with entities pursuant to Section 27-2-12.6 NMSA 1978 [to negotiate] and negotiates a rate for the reimbursement for services rendered to medicaid patients in the medicaid managed care system; and provided further that a higher rate of reimbursement may be given for services to medicaid patients in medically underserved areas, as determined by regulation adopted by the department. "
