MAKING AN APPROPRIATION FOR RESEARCH AND PUBLIC SERVICE PROJECTS
AT THE UNIVERSITY OF NEW MEXICO HEALTH SCIENCES CENTER.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. --

A. One million six hundred thirty-nine thousand one hundred dollars (\$1,639,100) is appropriated from the general fund to the board of regents of the university of New Mexico for expenditure in fiscal year 1998 in the following amounts for the following purposes:

- (1) three hundred eighty-nine thousand five hundred dollars (\$389,500) to hire additional staff to support research objectives at the health sciences center;
- (2) three hundred eighty-one thousand five hundred dollars (\$381,500) to continue and expand the enrollment

of the certified nurse-midwifery program at the health sciences center;

- (3) four hundred six thousand dollars (\$406,000) for equipment costs and additional staff for the telemedicine program;
- (4) one hundred two thousand eight hundred dollars (\$102,800) to fund additional staff positions and other costs for the nurse distance education program; and
- (5) three hundred fifty-nine thousand three hundred dollars (\$359,300) for coordinating and increasing support for area health education programs.
- B. Any unexpended or unencumbered balance remaining at the end of fiscal year 1998 shall revert to the general fund.
