AN ACT

MAKING AN APPROPRIATION TO THE SECOND JUDICIAL DISTRICT TO STUDY
THE CONSOLIDATION OF THE DISTRICT COURT AND METROPOLITAN COURT
INTO A UNIFIED COURT FOR BERNALILLO COUNTY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- Two hundred thousand dollars
(\$200,000) is appropriated from the general fund to the second
judicial district for expenditure in fiscal year 1998 to study
the feasibility of a unified court in Bernalillo county. The
second judicial district shall keep the interim courts,
corrections and criminal justice committee apprised of the
study's progress and make a final report, including
recommendations, to the committee and the legislature by
November 1, 1997. Any unexpended or unencumbered balance
remaining at the end of fiscal year 1998 shall revert to the
