MAKING AN APPROPRIATION FOR THE UNIVERSITY OF NEW MEXICO MANUFACTURING ENGINEERING PROGRAM.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- Five hundred thousand dollars (\$500,000) is appropriated from the general fund to the board of regents of the university of New Mexico for expenditure in fiscal year 1998 for the purpose of supporting the manufacturing training and technology center cleanroom and semiconductor manufacturing process training of the university's manufacturing engineering program. Any unexpended or unencumbered balance remaining at the end of fiscal year 1998 shall revert to the general fund.
