AN ACT

MAKING AN APPROPRIATION TO ESTABLISH A CENTER FOR BIOMECHANICS AT THE UNIVERSITY OF NEW MEXICO.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- Four hundred forty-six thousand three hundred dollars (\$446,300) is appropriated from the general fund to the board of regents of the university of New Mexico for expenditure in fiscal year 1998 for the purpose of establishing a center for biomechanics at the university of New Mexico for specialized training of orthopedic surgeons and therapists and to improve clinical care opportunities to patients with musculoskeletal disorders. Any unexpended or unencumbered balance remaining at the end of fiscal year 1998 shall revert to the general fund.
