AN ACT

RELATING TO MUNICIPALITIES; REQUIRING CERTAIN MUNICIPALITIES TO
CONDUCT AN ELECTION PRIOR TO CHANGING THE ZONING OR USE OF
CERTAIN AREAS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. A new section of the Municipal Code is enacted
to read:

" NEW MATERIAL CERTAIN MUNICIPALITIES--CHANGING THE
ZONING OR USE OF CERTAIN AREAS--ELECTION REQUIRED. --No
municipality that has a population of one thousand five hundred
or less at the last federal decennial census and that is
partially bordered, at the time of that census, by federal land
managed by the United States forest service, shall change the
zoning or use of any land acquired without first submitting the
question to the voters at a general election or at a special

2 A. was acquired by the municipality from or with the
3 permission of the United States forest service;

4 B. lies adjacent to the municipality's geographical
