AN ACT

RELATING TO THE PUBLIC SCHOOL CAPITAL OUTLAY COUNCIL; CHANGING  
MEMBERSHIP ON THE PUBLIC SCHOOL CAPITAL OUTLAY COUNCIL.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. Section 22-24-6 NMSA 1978 (being Laws 1975,  
Chapter 235, Section 6, as amended) is amended to read:

"22-24-6. COUNCIL CREATED-- ORGANIZATION-- DUTIES. --

A. There is created the "public school capital  
outlay council", consisting of ~~the~~:

(1) the secretary of finance and administration  
or his designee;

(2) the state superintendent or his designee;

(3) the governor or his designee;

(4) the president of the New Mexico school  
boards association or his designee;

4 (6) the president of the state board or his

6 (7) the director of the legislative education  
7 study committee or his designee;

10 ~~(9) the director of the legislative council  
11 service or his designee]~~

12 (8) a person with experience in public finance  
13 to be appointed by the New Mexico legislative council; and

14 (9) a person with experience in a construction  
15 trade or construction management to be appointed by the New  
16 Mexico legislative council.

17 B. The council shall investigate all applications  
18 for assistance from the fund and shall certify the approved  
19 applications to the secretary of finance and administration for  
20 distribution of funds.

21 C. The council shall elect a chairman from among the  
22 members. The council shall meet at the call of the chairman.

23 D. The department of education shall account for all  
24 distributions and shall make annual reports to the legislative  
25 education study committee and to the legislative finance
