| 17 | Section 1. SEVERANCE TAX BONDSPURPOSE FOR WHICH ISSUED |
| 18 | APPROPRIATION OF PROCEEDS |
| 19 | A. The state board of finance may issue and sell |
| 20 | severance tax bonds in compliance with the Severance Tax Bonding |
| 21 | Act in an amount not exceeding three million eight hundred |
| 22 | twenty-eight thousand two hundred eighty-two dollars |
| 23 | (\$3,828,282) when the state agency on aging certifies the need |
| 24 | for the issuance of the bonds. The state board of finance shall |
| 25 | schedule the issuance and sale of the bonds in the most |

1 expeditious and economical manner possible upon a finding by the board that the project has been developed sufficiently to 2 justify the issuance and that the project can proceed to 3 contract within a reasonable time. The state board of finance 4 shall further take the appropriate steps necessary to comply 5 6 with the Internal Revenue Code of 1986, as amended. The 7 proceeds from the sale of the bonds are appropriated to the state agency on aging in the following amounts for the following 8 9 purposes:
