2	B. Payment or reimbursement may be made pursuant to

5	(1) the service performed is within the lawful

7	(2) the coverage provides for reimbursement for
8	identical services performed by other licensed health care
9	provi ders.
10	C. Nothing in this section shall require the plan to
11	pay a claim to more than one provider for duplicate service or
12	be interpreted to limit physician reimbursement."
