UNDERGRADUATES MAJORING IN ENGINEERING, MATHEMATICS AND SCIENCE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- Two hundred fifty thousand dollars (\$250,000) is appropriated from the general fund to the board of regents of the university of New Mexico for expenditure in fiscal year 1998 for the purpose of funding a program that provides undergraduate minority students with academic support services for mathematics, engineering and science curricula to enhance students' problem-solving skills, encourage academic excellence and improve retention rates. Any unexpended or unencumbered balance remaining at the end of fiscal year 1998 shall revert to the general fund.
