RELATING TO MOTOR VEHICLES; AMENDING SECTION 66-5-21 NMSA 1978

(BEING LAWS 1978, CHAPTER 35, SECTION 243, AS AMENDED) TO REQUIRE THE MOTOR VEHICLE DIVISION TO ALLOW FOR ALL DRIVERS A GRACE PERIOD OF THIRTY DAYS AFTER THE DRIVER'S BIRTH DATE BEFORE EXPIRATION OF DRIVERS LICENSES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. Section 66-5-21 NMSA 1978 (being Laws 1978, Chapter 35, Section 243, as amended) is amended to read:

"66-5-21. EXPIRATION OF LICENSE--FOUR-YEAR ISSUANCE
PERIOD.--All driver's licenses shall be issued for a period of
four years, except those provided for in Section 66-5-19 NMSA
1978 and as otherwise provided in Section 66-5-67 NMSA 1978, and
each license shall expire thirty days after the applicant's
birthday in the fourth year after the effective date of the

shall expire thirty days after the applicant's birthday in the year in which the license expires. [The] Each license is renewable within ninety days prior to its expiration or at an earlier date approved by the department. The fee for the license shall be as provided in Section 66-5-44 NMSA 1978. The department may provide for renewal by mail pursuant to rules adopted by the department and may require an examination upon renewal of the driver's license."
