MAKING AN APPROPRIATION TO THE LEGISLATIVE COUNCIL SERVICE FOR  
ADDITIONAL AUTOMATION NEEDS FOR THE LEGISLATIVE INFORMATION  
SYSTEM

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- Eight hundred ten thousand  
dollars (\$810,000) is appropriated from the general fund to the  
legislative council service for expenditure in fiscal years 1998  
and 1999 for the legislative information system for replacement  
workstations for the legislative council service, the  
legislative education study committee, the legislative finance  
committee, the house of representatives and the senate; for  
network infrastructure; and for legislative notebooks and other  
attendant hardware and software upgrades to enhance  
communications equipment for support of the legislative web site

1 and other communications applications and upgrades to internal  
2 systems. Any unexpended or unencumbered balance remaining at  
3 the end of fiscal year 1999 shall revert to the general fund.
