(3) the vehicle identification number;
(4) the name and address of the insurance
agent;
(5) the name of the insurance company;
(6) the insurance policy number; and
(7) the policy expiration date.
C. Insurance exchange cards containing current
information shall be provided to policyholders with each new
issuance of an evidence of financial responsibility card."
