AN ACT

MAKING AN APPROPRIATION FOR OPERATIONAL COSTS OF THE WORKFORCE
DEVELOPMENT CENTER AT THE ALBUQUERQUE TECHNICAL-VOCATIONAL
INSTITUTE IN BERNALILLO COUNTY; DECLARING AN EMERGENCY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. --Fifteen thousand dollars
(\$15,000) is appropriated from the general fund to the governing
board of the Albuquerque technical-vocational institute for
expenditure in fiscal years 1997 and 1998 for the purpose of
funding operations of the workforce development center of the
Albuquerque technical-vocational institute in Bernalillo county.
Any unexpended or unencumbered balance remaining at the end of
fiscal year 1998 shall revert to the general fund.

Section 2. EMERGENCY. --It is necessary for the public
peace, health and safety that this act take effect immediately.
