SEVERANCE TAX BONDS--STATE DEPARTMENT OF PUBLIC EDUCATION--CHANGE IN PURPOSE--APPROPRIATION.--The balance of severance tax bonds appropriated to the state department of public education pursuant to Subsection V of Section 12 of Chapter 4 of Laws 1996 (1st S.S.) for the purpose of purchasing or installing computer technology at St. Catherine Indian school in Santa Fe located in Santa Fe county shall not be expended for its original purpose but is reauthorized and appropriated to the state department of public education for the purpose of purchasing and distributing instructional material, pursuant to

the provisions of the Instructional Material Law, in order to provide computer technology to qualified students attending St. Catherine Indian school located in Santa Fe in Santa Fe county.

Section 2. EMERGENCY.--It is necessary for the public peace, health and safety that this act take effect immediately.
