23	interim debentures as provided in Sections 72-16-46 and 72-16-89
24	through 72-16-91 NMSA 1978, shall be created by the authority
25	without first submitting a proposition of issuing such bonds to

6	series or more and may mature at such time or times not
7	exceeding forty years from their issuance as the board may

10	<u>sixty million dollars (\$60,000,000)</u> without prior approval of
11	the state legislature."
