operated for the corrections department pursuant to a contract,
unless the substance was obtained pursuant to a valid

analog or counterfeit substance while on the premises of a
correctional facility operated by the corrections department or
operated for the corrections department pursuant to a contract.

Section 2. EFFECTIVE DATE. -- The effective date of the provisions of this act is July 1, 1997.
