BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- One hundred fifty-five thousand dollars (\$155,000) is appropriated from the general fund to the board of regents of eastern New Mexico university for expenditure in fiscal year 1998. Any unexpended or unencumbered balance remaining at the end of fiscal year 1998 shall revert to the general fund. The money is appropriated for the following purposes:

- A. to conduct a feasibility analysis and prepare a plan to improve the administrative computing system hardware and software;
- B. to purchase and install student financial aid software;
