16	Section 1. Section 53-8-17 NMSA 1978 (being Laws 1975,
17	Chapter 217, Section 17) is amended to read:
18	"53-8-17. BOARD OF DIRECTORSThe affairs of a
19	corporation shall be managed by a board of directors. <u>The</u>
20	directors may adopt and implement provisions that regularly
21	identify and serve the interests and needs of the population
22	served by the corporation. These provisions may include the
23	appointment of persons to the board of directors who reasonably
24	reflect the ethnic, economic, gender, geographic and
25	professional diversity of the population the corporation serves.

1	Directors need not be residents of New Mexico or members of the			
2	corporation unless the articles of incorporation or the bylaws			
3	so require. The articles of incorporation or the bylaws may			
4	prescribe other qualifications for directors and may require			
5	<u>that boards of directors adopt ethical standards similar to</u>			
6	those standards required of a legislator, public officer or			
7	<u>employee</u> . "


