AN ACT

MAKING AN APPROPRIATION TO THE DRINKING WATER STATE REVOLVING LOAN FUND FOR DRINKING WATER SYSTEM FINANCING; DECLARING AN EMERGENCY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- Pursuant to Section 6-21-6.1 NMSA 1978, two million six hundred thousand dollars (\$2,600,000) is appropriated from the public project revolving fund to the drinking water state revolving loan fund for expenditure in fiscal years 1997 and 1998 to carry out the purposes of the Drinking Water State Revolving Loan Fund Act. Any unexpended or unencumbered balance remaining at the end of fiscal year 1998 shall not revert to the general fund.

Section 2. CONTINGENT EFFECTIVE DATE. -- The provisions of this act are contingent upon the enactment of a bill passed by

the	first session of the forty-third legislature and signed into
l aw	enacting the Drinking Water State Revolving Loan Fund Act
and	establishing the drinking water state revolving loan fund.

Section 3. EMERGENCY.--It is necessary for the public peace, health and safety that this act take effect immediately.
