- B. There is imposed a tax upon the privilege of exhibiting for an admission fee any live professional contest, except a live professional boxing contest held in New Mexico on a closed-circuit telecast or motion picture. [a tax at] The rate of the tax imposed is five percent of the gross receipts derived [therefrom] from the exhibition.
- C. The privilege tax imposed in this section shall be administered, collected, enforced and the proceeds deposited as provided in Section [60-2A-23] 60-2A-24 NMSA 1978."
- Section 2. EMERGENCY.--It is necessary for the public peace, health and safety that this act take effect immediately.
