#### AN ACT

MAKING AN APPROPRIATION FOR A PROGRAM TO PERMIT ACQUISITION OF A HIGH SCHOOL DIPLOMA IN A COLLEGE SETTING THROUGH THE SANTA FE PUBLIC SCHOOLS; DECLARING AN EMERGENCY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION.--Two hundred forty-three thousand dollars (\$243,000) is appropriated from the general fund to the state department of public education for expenditure in fiscal years 1997 and 1998 for the purpose of supporting a program to permit students to complete their high school diploma requirements while preparing for an associate of arts college degree through the Santa Fe public schools. Any unexpended or unencumbered balance remaining at the end of fiscal year 1998 shall revert to the general fund.

Section 2. EMERGENCY. -- It is necessary for the public
