(2) thirty-five million dollars (\$35,000,000) is appropriated from the general fund to the human services department for expenditure in fiscal year 1998 for the purpose of carrying out the provisions of the Family Assistance and Individual Responsibility Act. Any unexpended or unencumbered balance remaining at the end of fiscal year 1998 shall revert to the general fund.

B. The appropriation in Paragraph (2) of Subsection A of this section, together with other appropriations to the human services department, the children, youth and families department and the labor department in the General Appropriation Act of 1997, shall be used to meet the one hundred percent of the maintenance of effort required to obtain both the federal temporary assistance for needy families block grant and its contingency pursuant to the federal Personal Responsibility and Work Opportunity Reconciliation Act of 1996, Public Law 104-193.

C. The appropriations authorized in this section shall only take effect if the Family Assistance and Individual Responsibility Act is enacted into law by the first session of the forty-third legislature.
