16	Section 1. TEMPORARY PROVISIONSTUDYThe public school				
17	capital outlay council shall conduct a comprehensive study of				
18	public school capital outlay needs statewide. The study shall				
19	include development of guidelines and standards; an inventory				
20	and assessment of school facilities and infrastructure; cost				
21	estimates for repair, renovation and modernization of existing				
22	facilities; and an estimate of future facility needs. The study				
23	shall assess the equity and efficiency of current state and				
24	local processes used to fund public school facilities and				
25	recommend an equitable and efficient method by which to meet

public school capital outlay needs. A progress report shall be
presented to the legislative education study committee and the
legislative finance committee by November 1, 1997 and the final
report by June 30, 1998.

Section 2. APPROPRIATION. --Five hundred thousand dollars (\$500,000) is appropriated from the general fund to the state department of public education for expenditure in fiscal years 1997 and 1998 for the purpose of conducting a study of public school capital outlay facilities and infrastructure as provided in Section 1 of this section. Any unexpended or unencumbered balance remaining at the end of fiscal year 1998 shall revert to the general fund.

Section 3. EMERGENCY.--It is necessary for the public peace, health and safety that this act take effect immediately.


