The proceeds from the sale of the bonds are appropriated to the state highway and transportation department for the purpose of completing a feasibility study for a bypass loop north of Gallup located in McKinley county. unexpended or unencumbered balance remaining at the end of fiscal year 2000 shall revert to the severance tax bonding fund. If the state highway and transportation department has not certified the need for the issuance of the bonds by the end of fiscal year 1999, the authorization provided in this section shall be void.
