district division two shall be filled by appointment by the governor. The appointed magistrate shall begin serving January 1, 1998 and shall serve until succeeded by a magistrate elected pursuant to Subsection B of this section.

B. The first full term of the office of magistrate

B. The first full term of the office of magistrate in the Sierra magistrate district division two shall be filled by election at the general election in 1998, and that term of office shall begin on January 1, 1999.

Section 3. APPROPRIATION. -- Seventy thousand dollars (\$70,000) is appropriated from the general fund to the administrative office of the courts for expenditure in fiscal year 1998 for salary, benefits, office space and supplies for one new magistrate judge in the Sierra magistrate district division two. Any unexpended or unencumbered balance remaining at the end of fiscal year 1998 shall revert to the general fund.
