Section 1. APPROPRIATION. -- Two hundred fifty thousand dollars (\$250,000) is appropriated from the general fund to the state department of public education for expenditure in fiscal year 1998 for the purpose of funding teacher and administrator summer academies designed to provide participants with workrelated experiences for use in classroom instruction. Expenditure of this appropriation is contingent upon obtaining an equal or greater amount of matching funds from sources other Any unexpected or unencumbered balance than state funds. remaining at the end of fiscal year 1998 shall revert to the general fund.
