economic development department for expenditure in fiscal year 1998 for the purpose of providing personal services, supplies, materials or contractual services necessary to establish a trade office in the city of Taipei, Republic of China. Any unexpended or unencumbered balance remaining at the end of fiscal year 1998 shall revert to the general fund.

Section 3. APPROPRIATION. -- Two hundred fifty thousand dollars (\$250,000) is appropriated from the general fund to the economic development department for expenditure in fiscal year 1998 for the purpose of providing personal services, supplies, materials or contractual services necessary to establish a trade office in Tokyo, Japan. Any unexpended or unencumbered balance remaining at the end of fiscal year 1998 shall revert to the general fund.
