| 19 | A. The state board of finance may issue and sell |
| 20 | severance tax bonds in compliance with the Severance Tax Bonding |
| 21 | Act in an amount not exceeding six hundred thirty-seven thousand |
| 22 | five hundred dollars (\$637,500) when the state agency on aging |
| 23 | certifies the need for the issuance of the bonds. The state |
| 24 | board of finance shall schedule the issuance and sale of the |

upon a finding by the board that the project has been developed sufficiently to justify the issuance and that the project can proceed to contract within a reasonable time. The state board of finance shall further take the appropriate steps necessary to comply with the Internal Revenue Code of 1986, as amended. The proceeds from the sale of the bonds are appropriated to the state agency on aging in the following amounts for the following purposes:

(1)four hundred ninety-one thousand two hundred dollars (\$491,200) for designing, planning, constructing and equipping, including parking, paving and kitchen equipment 12 purchase and installation, for a senior center in Roswell in 13 Chaves county;

ninety-one thousand dollars (\$91,000) for (2) purchasing and equipping transportation vans for a senior center in Roswell in Chaves county; and

fifty-five thousand three hundred dollars (3) (\$55,300) for completion of the new senior center, including fencing, installation of a canopy and storage shed, parking lot paving and curbing and an irrigation sprinkler system, at a senior center in Lake Arthur in Chaves county.

If the state agency on aging has not certified B. the need for the issuance of the bonds by the end of fiscal year 1999, the authorization provided in this section shall be void. Any unexpended or unencumbered balance remaining from the
