7	Section 2. APPROPRIATIONOne hundred forty-five thousand
8	four hundred dollars (\$145,400) is appropriated from the general
9	fund to the administrative office of the district attorneys for
10	expenditure in fiscal year 1998 for the purpose of paying
11	salaries and benefits for district attorneys. Any unexpended or
12	unencumbered balance remaining at the end of fiscal year 1998
13	shall revert to the general fund.
14	Section 3. EFFECTIVE DATEThe effective date of the
15	provisions of this act is July 1, 1997.
