16	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:
17	Section 1. Section 10-11-118 NMSA 1978 (being Laws 1987,
18	Chapter 253, Section 118, as amended) is amended to read:
19	"10-11-118. COST OF LIVING ADJUSTMENTS
20	A. For the purposes of this section:
21	(1) "preceding calendar year" means the twelve-
22	month period ending on [the] December 31 preceding the July 1 in
23	which pensions are being adjusted; and
24	(2) "second preceding calendar year" means the
25	full calendar year prior to the preceding calendar year.

The amount of pension payable to a qualified pension recipient shall be increased three percent each July 1. 2 The amount of the increase shall be determined by multiplying 3 the amount of pension inclusive of all prior adjustments by 4 three percent. 5 С. A qualified pension recipient is: 6 a normal retired member who has been (1)7 retired for at least two full calendar years from the effective 8 9 date of the latest retirement prior to July 1 of the year in 10 which the pension is being adjusted; 11 (2)a normal retired member who has attained 12 age sixty-five years and been retired for at least one full 13 calendar year from the effective date of the latest retirement 14 prior to July 1 of the year in which the pension is being 15 adjusted; 16 a disability retired member who has been (3) retired for at least one full calendar year from the effective 17 18 date of the latest retirement prior to July 1 of the year in 19 which the pension is being adjusted; a survivor beneficiary who has received a 20 (4) survivor pension for at least two full calendar years; [or] 21 a survivor beneficiary of a deceased 22 (5) 23 retired member who otherwise would have been retired at least two full calendar years from the effective date of the latest 24 25 retirement prior to July 1 of the year in which the pension is . 112990. 1
