#### AN ACT

RELATING TO COUNTY FUNDS; PERMITTING CERTAIN FUNDS TO BE USED FOR BURIAL OF INDIGENTS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. Section 24-13-3 NMSA 1978 (being Laws 1939, Chapter 224, Section 3, as amended) is amended to read:

"24-13-3. EXPENSES FOR BURIAL.--The expenses for the burial or cremation of an indigent person may be paid by the county out of the general fund or from the county indigent hospital claims fund in an amount up to six hundred dollars (\$600) for the burial of any adult or minor."

Section 2. Section 27-5-7.1 NMSA 1978 (being Laws 1993, Chapter 321, Section 16) is amended to read:

"27-5-7.1. COUNTY INDIGENT HOSPITAL CLAIMS FUND--AUTHORIZED USES OF THE FUND.--

- [C.] <u>D.</u> Until June 30, 1996, the cash reserves from the fund may be used to meet the county's obligation under Section 27-10-4 NMSA 1978."
