AN ACT

MAKING AN APPROPRIATION TO CONTINUE AND EXPAND THE  
ACCOUNTABILITY INFORMATION SYSTEM PILOT PROJECT CURRENTLY BEING  
CONDUCTED BY THE STATE DEPARTMENT OF PUBLIC EDUCATION AND SCHOOL  
DISTRICTS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

Section 1. APPROPRIATION. -- One hundred sixty thousand  
dollars (\$160,000) is appropriated from the general fund to the  
state department of public education for expenditure in fiscal  
year 1998 for the purpose of purchasing materials and software  
and contractual services associated with the expansion of an  
accountability information system pilot project to meet state  
and federal data requirements currently being conducted in  
school districts around the state. The accountability  
information system shall include the Native American database.
