APPROPRIATION. -- Fifty thousand dollars Section 2. (\$50,000) is appropriated from the general fund to the local government division of the department of finance and administration for expenditure in fiscal year 1998 by the acequia commission for the purpose of carrying out the commission's powers and duties. Any unexpended or unencumbered balance remaining at the end of fiscal year 1998 shall revert to the general fund.
