

11	RELATING TO EDUCATION; AMENDING A SECTION OF THE PUBLIC SCHOOL
12	FINANCE ACT TO MANDATE PROGRAM BASED BUDGETING.

14	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:
15	Section 1. Section 22-8-9 NMSA 1978 (being Laws 1967,
16	Chapter 16, Section 63, as amended) is amended to read:
17	"22-8-9. BUDGETSMINIMUM REQUIREMENTS
18	A. No budget for a school district shall be approved
19	by the department that does not provide for:
20	(1) a school year consisting of at least one
21	hundred eighty full instructional days or the equivalent
22	thereof, exclusive of any release time for in-service training;

24	(2) a variable school year consisting of a
25	minimum number of instructional hours established by the state

a pupil-teacher ratio or class or teaching (3) 2 load as provided in Section 22-2-8.2 NMSA 1978; and 3 effective July 1, 1997, a full-time, (4) 4 department-certified nurse for each fifty-five teachers employed 5 by a school district or the equivalent part-time, department-6 certified nurse for less than fifty-five teachers. 7 B. No budget for a school district shall be approved 8 by the department that does not provide for a program-based 9 budget for each school in the district and for the district as a 10 whol e. 11 [B.] C. The state board shall, by regulation, 12 establish the requirements for a teaching day, the standards for 13 an instructional hour and the standards for a full-time 14 certified classroom instructor and for the equivalent thereof. 15 [C.] D. The local school board shall submit a plan 16 for the implementation of an alternate school year to the state 17 superintendent for his approval. 18 $[\mathbf{D}, \mathbf{D}]$ E. The provisions of Subsection $[\mathbf{C}]$ D and 19 Paragraph (2) of Subsection A of this section shall be construed 20 to apply only to school districts with a MEM of one thousand or 21 fewer." 22 APPLICABILITY. -- The provisions of this act Section 2. 23 apply to budgets for fiscal year 1999 and subsequent fiscal 24 years. 25
