The corrections department shall include terms in **B**. 4 5 any contract entered into pursuant to Subsection A of this 6 section to ensure that inmates transferred to the United Mexican States are treated in a humane manner. 7 The corrections department shall also require documentation from any public or 8 9 private entity it contracts with that any inmate transferred to 10 the United Mexican States remains incarcerated for the duration 11 of his sentence.

Section 2. EFFECTIVE DATE.--The effective date of the provisions of this act is July 1, 1997.
